Item 1: Would ONTC advise if a Patterson-Kelley would be considered as an equal to Boiler Schedule Tags: BLR-1,2,3 specified Viessmann?

Answer: No, ONTC advises that it will not consider a Patterson-Kelley as an equal to Boiler Schedule Tags: BLR-1,2,3 specified Viessmann since It has a 10:1 turndown as opposed to a 20:1 turndown.

Item 5: Would ONTC consider Airtherm equipment as an equal to the unit heaters, cabinet heaters and fan coil unit?

Answer: Yes, ONTC will consider the above-noted as an equal.

Item 6: Would ONTC consider the Thermal Solutions AMP2000 Boiler as an equal to the Viessmann Vitocrossal 200 CL2?

Answer: No, ONTC will not consider the Thermal Solutions AMP2000 Boiler as an equal to the Viessman Vitocrossal 200 CL2. The Thermal Solutions AMP2000 Boiler has a bigger footprint than the boiler specified and may cause interferences. It also has a 5:1 turndown as opposed to a 20:1 turndown.

Item 7: Would ONTC consider Taco as an equal to Hydronic Schedule Tag: HS-1 specified Spirotherm?

Answer: Yes, ONTC will consider Taco as an equal to Hydronic Schedule Tag: HS-1 specified Spirotherm.

Answer: Yes, ONTC advises that Engineered Air, Sterling Hydronics could be considered as an equal to Wall-Fin Radiation Schedule Tag: WF-1.1 thru Wf-1.13 specified Rosemex

Item 14: ONTC indicates that the work in connection with drawing S01 from the structural drawings has been completed and therefore, this drawing shall no longer form part of the RFP package.

Item 15: ONTC advises that the work associated with the concrete pad for the heat exchanger and pump in drawing S02 detail 1, is no longer required and therefore, is to be removed from the drawing.

Item 16: Would ONTC please confirm whether or not controls other than Honeywell would be considered as equals or alternatives in terms of the integration with the existing BAS system?

Answer: ONTC advises that the existing BAS system at ONTC is Honeywell-EBI and the intent is to integrate the new controls into the existing BMS system. If the contractor chooses to utilize controls brands other than Honeywell, those controls shall have the capacity to be integrated into Honeywell BMS system. ONTC will not consider using another BAS front end server
